California Charter Authorizing Professionals (CCAP)

- Founded by group of **committed authorizers to advance quality public education for all students**
 - Started CARNet as an entity to implement an earlier grant
- Now **National Dissemination Grant** from U.S. Department of Education's Charter Schools Program to improve authorizing
 - Partnering with **Colorado and Florida** in **Tri-State Alliance for Improving District-Led Authorizing**
 - Has formed **National Network for District Authorizing (NN4DA)**
- **Charter Authorizing 2.0: Advancing Equity and Access Through Quality Authorizing**

Why Your Action is Needed Now

- A3 Charter School Fraud – It is impacting all authorizers
- Needs of small authorizers
 - Some authorizing realities
- Impact of COVID and lack of statewide academic data
- Gift of the two-year extension on renewals

County Board's Role

- Decision-maker
- Collaboration with superintendent and staff
- Making sure you get the information you need to make high quality decisions
- Oversight - create clear and positive relationships
- Ongoing review of the performance of the charter school(s)
- Key considerations:
 - Working with the County Superintendent
 - Appeals from district boards
 - “De novo” review

County Boards and Superintendents - Collaboration & Cooperation Essential!

- County Board Members are elected officials (typically)
- County Superintendents of Schools are elected officials (typically)
- Boards approve or deny charters or renewals
- Superintendents have direct responsibility for the staff of County Offices of Education -- and typically for the oversight of charter schools approved by the Board
 - Staff expertise and greater level of detail than Board

Your Special Role: Appeals from Denial of a Petition

- From school district to COE
- From COE to SBE (except countywide)
- COE Now Has Final Substantive Appeal
- District role:
 - Provide documentation of denial
 - Offered an opportunity to speak; can provide public comment
- Not judging the district's decision – *de novo review*
- Often difficult role for the board AND staff

COVID-19 Has Changed EVERYTHING

- Hard to overstate how much COVID-19 has disrupted K-12 education
- Widespread and deep learning loss
- State and federal priorities
- Charter school oversight (Job 1? – NOT!)

Changes in Law

- SB 126, AB 1505, AB 1507, SB 130 and AB/SB 167
- Charter School Approval
- Charter (Oversite and) Renewal
- Continued Pandemic "Fixes"

Discussion of Legislative Changes - Charter Approval

- District/County has 30 more days to consider charter petition or renewal
 - Clock starts on date petition submitted
 - **Staff findings must be published 15 days before public hearing**
 - Equal time for petitioners at public hearing

Discussion of Legislative Changes - Charter Approval

- New criteria for denial of a new petition (not renewal)
 - **Not serve the interest of the entire community**
 - Would substantially undermine existing district services
 - Is the district not able absorb the fiscal impact of the proposed charter school
 - **Qualified interim certification, negative certification or is under receivership**

Discussion of Legislative Changes - Charter Approval

- Additional Charter Petition Elements
 - Tighter alignment to the goals and outcomes of the state dashboard priorities
 - Expand the means to achieve a racial and ethnic balance to include English Learners and students with disabilities
 - As supplemental information, the names and qualifications for the charter's nonprofit governing board
 - **Requires a charter school that seeks to add additional grade levels to submit this as a material change**
 - **Removes charter school flexibility for teachers, requiring the same credentialing (exemption until June 30, 2025 of existing staff)**

Discussion of Legislative Changes - Charter Approval

➤ Charter Appeals

- Appeals must be submitted within 30 days
- The new timelines for considering new petitions also apply to appeals
- Two new criteria for denial of new petitions also apply to appeals
- Clarifies what updated information can be submitted with an appeal
- **Includes a remand to the district if substantive changes are made**
- **Continues de novo review by the county (but must review fiscal impact)**

Discussion of Legislative Changes - Charter Approval

- Charter Appeals
 - **State Board Appeals have changed significantly**
 - **New standard of review is “abuse of discretion”**
 - Exception is for districts that are also counties
- County-wide Benefit Charters
 - No substantive changes except to conform with the procedural changes made for petitions submitted to district

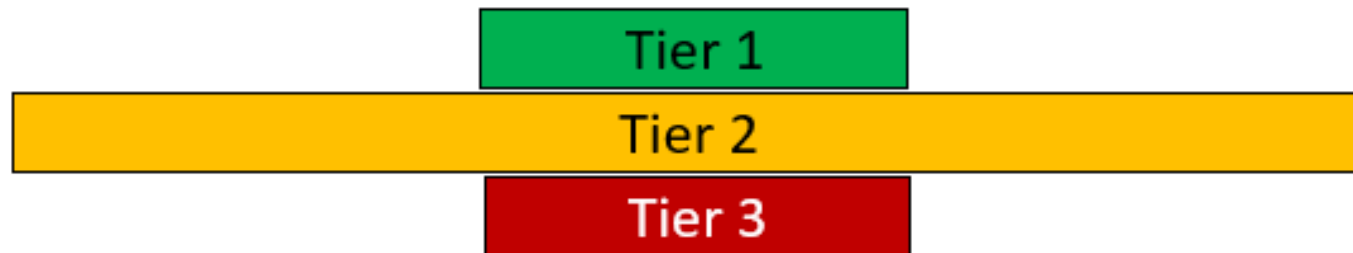


California School

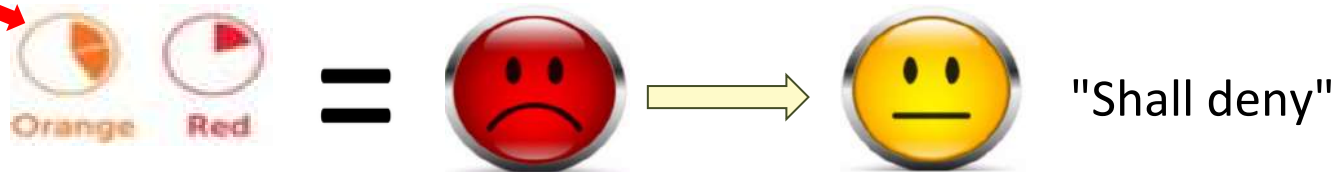
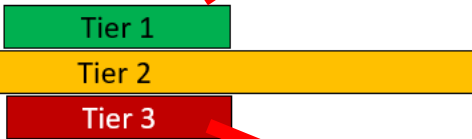

- Any major issues/ concerns must follow NOV
- 5-7 years



- "Clear and convincing evidence": Strong plan and growth = 2 years

Authorizer Priorities COVID Recovery

- Recognize these are extraordinary times; be flexible and supportive
- School's Focus on learning acceleration/recovery and student equity issues
- If schools have serious problems, deal with them; especially in the fiscal and governance/management areas
- Renewal Planning – Valid Academic Measures – DO NOW!

CA2.0 - Authorizer Toolkits

- Development: Meetings with CCAP and authorizing staff from across CA
- Intended as foundation and resource for district and county authorizers, to be adjusted to own context and practices
- Incorporate legal requirements as well as best and promising practices
- Focus on equity and access: particular focus on English language learners

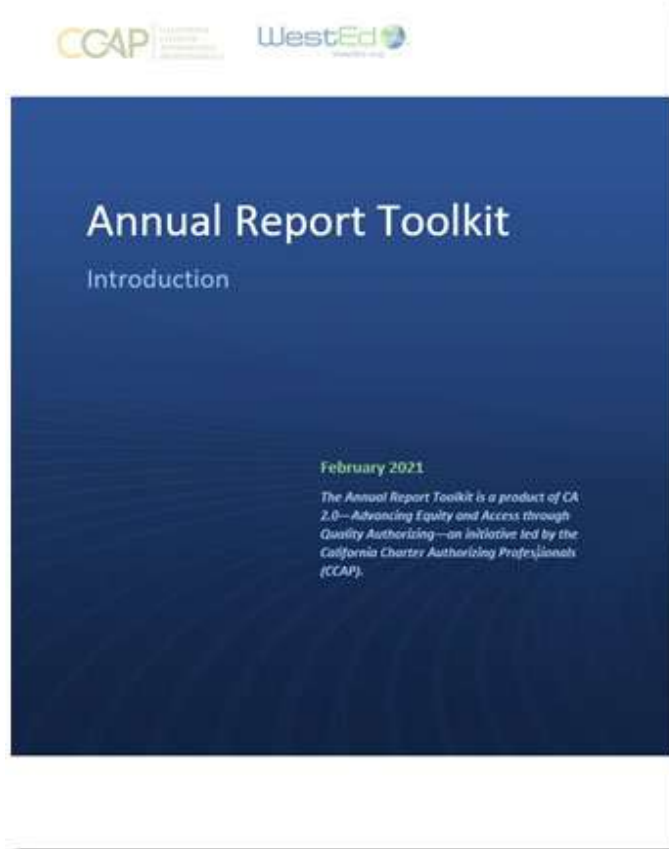

Highlight: Annual Report

- Purpose
 - Convey the charter school's annual performance and performance trend over time
 - Assess the charter school's performance in light of renewal
 - Initiate a conversation with charter school, differentiate oversight, install a plan if necessary
- Annual Performance Report: Ingredients
 - Summary of school and school performance
 - Academic, Operations, and Financial
 - Inclusion of non-rated narrative addressing the fourth Core Performance Question
 - LCAP summary and overall Strengths/Areas for Improvement
- Detailed attachments include
 - Completed Academic, Operations and Governance, and Financial Health frameworks
 - Site visit report

Academic Performance: Is the charter school's education program a success?

This section provides an overview of the school's performance in the year reviewed on a variety of academic measures the school is accountable for achieving. Notably, the academic expectations are aligned with the standards for renewal pursuant to state law.

- Two-year pause is a great opportunity to review practices
